- Supporting and empowering individuals, families and communities to take appropriate action to influence health care
- Working with multidisciplinary and multiagency team members to ensure delivery of health care plans and programmes
- Delivering evidence based care to individuals, families and communities in a variety of settings e.g. home environments, clinics, practice surgeries, children's centres
- Reviewing child growth and development and referring appropriately to other services
- Providing screening, immunisation advice and health and development reviews in line with the Healthy Child Programme
- Providing healthy living education and support activities e.g. lifestyle choices, care and safety of drugs, care and safety of equipment, accident prevention, parenting skills
- Referring service users as appropriate to other professionals and services
- Continuously evaluating and reviewing health care plans and programmes in partnership with service users and other stakeholders
