Extremely pleased to see the quality and the progression of the students within the programmes of ITMB and BSc DTS (Degree Apprenticeships) at Leeds Beckett University for the academic year of 2019-20. It has been an extremely difficult and challenging year for all the tutors and academic team at Leeds Beckett and the programme team has been very responsive to the situation.

The level of the work and that of the quality of the assessment samples, including the innovative practices adopted by colleagues at Leeds Beckett (Jackie and the team) is well recommendable.

There has been a good range and distribution of types of assessment methods and styles adopted within the modules, which clearly matches that to the learning outcomes and the aims of the programme(s), some of which has been fairly new and innovative courses across the board, including that of the new programmes aligned within the department.

Given the situation this year with Covid19, the programme team were in place to revert to alternative assessment structure, while fully informing me about the changes and that of the impact that it may have to the student's overall grades - really commendable towards their effort and sheer enthusiasm to support their students.

The programme has a good combination of group work assessment and that of individual aspects to demonstrate and assess their learning outcomes related to individual modules and that of the programme.

I was quite impressed with the overall VLE (My Beckett) platform and that on different ways the module tutors were able to interact and communicate with the students.

Leeds Beckett and that of the programme team should be commended towards managing the consistency of the standards within the programme and that of the satisfaction of the students through the practical and skills based learning within their studies.

There is good involvement of the industry/companies supporting this programme, and that it demonstrates good networks and relationships with these partners. The moderation was effectively carried out across all the modules within the programme, and the consistency was managed throughout.
