**Most students seem to be engaged in 'education' as part of their employment. This means that their assignments and topics chosen, for analysis, relate to both their interests and career. I sat in on a presentation and found the standard of engagement insightful and reflective on related and relevant topics.**

**There was good practice in relation to feedback. Some using video and oral approaches. One module uses posters and a reflective journal to enhance the learning outcomes. I liked the variety of assessment procedures used on the course and would commend continued use of these approaches.**

**The curriculum seems appropriate for students who want to critically analyse topics relating to education. The generic approach, to educational practices, allows students to pick topics that are relevant to their employment and indeed interests. The methods of teaching and learning allow students to deconstruct topics in an analytical manner.**
