There was a good variety of methods of assessment which mapped student achievement well against the Common European Framework. The assessments were carried out rigorously and with equity of treatment of students. The process of sending me draft papers for comments was efficient. The audio of student presentations and dialogue between them and the tutor was good. I was impressed with colleagues' efficiency in facilitating electronic access to the sample papers in good time.
