1.6 Working in Partnership

We are committed to working in partnership with you and the Students' Union to provide you with an inclusive, safe and engaging learning environment, which is conducive to study for all our students and our staff. An important element of your time studying with us is your engagement in developing your learning. Your engagement and attendance on your course enables you to further your learning and supports your achievement, course completion and aspirations for the future. There is an expectation that students will attend, engage in their learning and submit for assessment. We provide support for you to maximise your time studying with us and to develop your learning, skills and abilities to support you in your chosen career path.

We seek active participation by all our students in the continuous enhancement of our courses and through our monitoring, annual review and enhancement processes. 2 Studying on this Course

MA Performance aims to expand and liberate your creative potential by encouraging the production of innovative practical work. Each module is designed to start a questioning process and to challenge and examine critically the existing context of contemporary international performance practice. This means that you will be challenged both to examine current practice and theory, and to create your own work as either a solo practitioner or part of an ensemble.

The MA aims to enable those of you who are already practitioners to challenge and clarify your practice. For those of you who are just starting out, it offers a set of critical and creative tools for the creation of new work, much of which will benefit and feed off the other arts disciplines in the School. As a student studying on MA Performance, you will be expected to develop a portfolio of performance works, which could be studio, site, paper and/or screen based.

2.2 Course Resources

Physical

Performing Arts has six dedicated black box studio spaces (City and Headingley). We also have access to professional venues such as Northern Ballet and Yorkshire Dance. With training, you have use of technical resources during the programme, with refresher courses and one-to-one training made available where appropriate for students at all levels. The University also provides a production budget for some technical resources and materials required for performance, set construction etc.

The Course also has specialist equipment for documenting performance, which can be loaned out, however you can also borrow equipment from the University's AV Loans as long as you have a valid Library Card and have no outstanding fines.

Industry Experts

All your course tutors are industry experts. In addition, we invite a number of leading performing arts industry professionals to work with you through the course of your studies. You will also carry out a Work Based Learning Placement that will position you to work alongside industry professionals in a real-life employment context. You also have access to some visiting lectures that are delivered across the School, and are encouraged to make use of the relevant industry-related talks and events that take place in regional arts and cultural industries venues.

Online

The Virtual Learning Environment (VLE) My Beckett is primarily used as a teaching repository where all Timetables, Assessment Briefs, Handouts, Web Links, Reading Lists and AV material are available for every module. Where appropriate (for example in Professional Practice modules) uses of discussion boards form a valuable part of module delivery. Written work is submitted via the VLE, to a specified deadline.

Library

Academic Librarians are responsible for the identification and selection of materials to support courses and research in their subject area. Our Library also works with other libraries to enable access for Leeds Beckett students and staff. An Interlibrary Loan service is available to staff, research students, taught masters students and undergraduates working on dissertations to facilitate access to information resources not held by The Library. The Library opens 24/7 every day of the year providing over 2100 study places of which approximately 800 offer access to computing or multi-media facilities with the latest operating software. Wireless networking is also available throughout The Library and wireless enabled laptop PCs are available for loan. Library Online provides access to information and resources available through The Library, including subject pages and Discover.

2.4 Work-Related Activities and Employability

Within the context of a drive to build beneficial partnerships the Performing Arts department, provides the opportunity for MA students to work with a range of performance practitioners and artists on small and medium-term, projects. The programme of professional work forms part of multiple modules, primarily in The Artist Mentor, but also in Performance Matters, and Artist Project series. Furthermore, many of the companies and artists will contribute to this provision in the form of workshops and discussions.

Students will also be able to undertake professional placement opportunities in a range of organisations and creative environments. Leeds Beckett has among others partnerships with Opera North, West Yorkshire Playhouse, Northern Ballet Theatre, Phoenix Dance Theatre, Red Ladder Theatre, Carriageworks, Leeds Carnival and Dean Clough. The course team has compiled a list of other regional, national, and international performance companies and organisations with whom placement opportunities exist.

Many potential MA students have articulated the desire to gain teaching experience as part of their professional development. Care has been taken to ensure that opportunities exist for students to shadow and collaborate with the existing staff team on selected undergraduate performance modules, which can also be framed as a professional placement.

2.5 Opportunities for Graduates

3 Assessment and Feedback

3.1 Assessment

Assessment Schedule

Examination

All assessment briefs can be found in module handbooks and are also launched during scheduled sessions and published to the VLE.

Coursework

Details of your course work are available in the Module Handbooks via the VLE.

Reasonable Adjustments and Assessment Support

Students with disabilities should contact Disability Advice at the earliest possible opportunity to discuss their support requirements for assessments and / or examinations.

Where adjustments are required in relation to examinations, Disability Advice should be contacted no later than **Friday 9 November 2018** in advance of the semester one exam period, and by **Friday 8 March 2019** in advance of the semester two exam period. This will provide the best chance of implementing the recommendations from the adjustment plan for that semester's main exam period. Where applications are made after these dates, we will try to put recommendations in place, but this may not always be possible. Please see Disability Advice on the 'Support' tab in MyBeckett for further information.

Submitting Assignments

Written assignments will be submitted using the VLE, unless for practical reasons this is impossible (e.g. a document that can't exist in a digital format), in which case submissions can be made to Northern Terrace Admin Office. Practical assignments will take place in appropriate space dependent on the needs of the project, during scheduled sessions. All submission deadlines are published in module handbooks.

It is important that you keep copies of all work submitted until after you have graduated. You should also keep any receipts confirming the submission of assignments. In the event of your submitted work being lost you may be required to produce a copy of the work and submission receipt. If you are unable to do so, your work will not be marked.

It is important to note that submitting all assignments is a requirement of your course. Should you experience extenuating circumstances which prevent you from submitting on time please make yourself aware of section 3.4 of this handbook. Without any form of extenuating circumstances, standard penalties apply for late submission of assessed work. Full details of the penalties for late submission of course work are available in section 3.11 of the Academic Regulations at www.leedsbeckett.ac.uk/public-information/academic-regulations.

If you have been recommended 'flexibility around deadlines' as a reasonable adjustment in your Reasonable Adjustment Plan, your Course Administrator will be able to advise you of the process.

Module tutors place Turnitin in MyBeckett modules to help you with your academic work. When you submit your work through Turnitin it will 'match' your work with a massive global

database of books, e-books, journals, websites and other students' work. You can see if parts of your work 'match' work in the database and you can see if you have attributed this to the source. Turnitin can only help you if you submit drafts of your work a reasonable length of time before the submission deadline.

However, please be aware that Turnitin guarantees to 'match' your work and return the result to you within 48 hours. Sometimes it may be quicker than this, but there is no guarantee. The second time you submit a draft of this work Turnitin guarantees that it will 'match' and return your work within 24 hours. Again it may be quicker, but do not rely on this. If you submit a third draft of the work through Turnitin it will again only guarantee a 'match' and return within 24 hours. Therefore, if you want to use Turnitin to help you check your work you must start to submit drafts for matching at least four days before the deadline.

Turnitin cannot detect plagiarism; it can only 'match' text. If you are not sure how to interpret the 'originality report', which Turnitin makes available to, you please ask your module tutor.

3.2 Getting Feedback on your Assessed Work

Assessed work will normally be returned with appropriate feedback within four weeks of your submission. Each Module Handbook will provide you with specific guidelines on how and when you will receive this. The Course Specification explains how feedback will be provided on both formative and summative assessments.

Modules include a 70% Continuous Assessment of Process and Practice/Contribution (workshops, performance, practical activities, writing, devising, making, creating) and 30% Reflection (written, viva voce, presentation, seminar). This 70/30 model is utilised throughout the study programme giving the student clear assessment expectations and providing maximum flexibility in a programme where content can differ from module/project to module/project. The rationale behind this model is that students are

assessed with emphasis on *process and journey* – it is the course team’s belief that this is where good learning happens and it is important not to focus wholly on ‘product’ or ‘final performance’ in modules. This means that formative feedback will be given continuously over each of your modules, in some instances this will be written, but in more practical classes formative feedback will be given to you verbally.

3.3 How do I Get my Results?

Results from module assessments and decisions on awards are available on the *Results Online* system from:

Results will only appear within *Results Online* five working days after the date of the Progression and Award Board meeting (the meeting where your end of level outcome will be decided) or the Module Board meeting (the meeting where modular outcomes are decided).

If you are unsure about when you might receive your results or have queries relating to your results, you should contact your Course Administrator.

3.4 Extenuating Circumstances and Mitigation

If you are experiencing problems which are adversely affecting your ability to study (called 'extenuating circumstances'), then you can apply for mitigation. The University operates a fit to sit/fit to submit approach to extenuating circumstances, which means students who take their assessment are declaring themselves fit to do so.

Examples of extenuating circumstances include personal or family illness, bereavement, family problems or being a victim of crime. You will need to provide evidence to prove your situation; the Students’ Union Advice Service can offer guidance on what evidence you will need to present.

You should contact the Course Director or Course Administrator if you need to discuss any issues that might be a barrier to you engaging fully in your studies.

3.5 Re-assessment

If you have not passed a module at the first attempt you will be eligible for re-assessment. See your Module Handbook for details of the relevant re-assessment process (e.g. whether it is coursework, an examination, a presentation or other form of assessment/when it will take place/what the deadline is). You will be advised via Results Online of your options for re-assessment. You are advised to contact your Course Director, Student Administrator or Academic Advisor for any necessary clarification.

3.6 Student Appeals

If you feel that you have in some way been disadvantaged during your studies and this is reflected in your results, then you may have grounds for an academic appeal.

After your results are available on Results Online, you have 15 working days to submit a request for an appeal hearing. You will find the information you need, including grounds for appeal, when and how to appeal and frequently asked questions at:

You are strongly advised to seek guidance from the Students' Union Advice Service on whether you have grounds for an appeal and the completion of the paperwork – see section 4 for Students' Union Advice Service contact details.

3.7 Academic Misconduct

Academic integrity is a fundamental principle within the University and is strongly linked to good academic practice. The University has processes to investigate alleged breaches of academic integrity and, where a breach of academic integrity is admitted or found, applies appropriate penalties.

Any attempt to gain an unfair advantage, whether intentional or unintentional, is a matter of academic judgement and may be considered to be a breach of academic integrity. Examples of unfair practice include, but are not limited to cheating, plagiarism, self-plagiarism, collusion, ghost writing and falsification of data. Definitions of these offences and the serious consequences of breaching academic integrity can be found in our Academic

4 Where to Get Help

4.1 Academic Advisor

Your academic advisor (see Key Contacts in section 1) will usually be an academic member of staff who teaches you on your course. Your Course Director will make sure that you are given the name and contact details of your academic advisor at the beginning of each year, usually in your course induction. Normally, your tutor will aim to follow you right through the duration of your course.

Your academic advisor has an important role to play in supporting you in academic and personal matters while you are studying on this course. The meetings will include discussion about career aspirations, your course, your progress, and your academic results. You may want to set objectives for academic and life goals, which you can store on your e-portfolio. Academic advisors are not trained counsellors and will signpost you to other University services if they can't help you. These services may, for example, be the Students' Union, the counselling service or the Student Hub.

In the first year, your tutor will probably initiate communication to request a meeting at a mutually convenient time, but later in your course, it should be your responsibility to set up the meeting. If you ask information to be kept confidential, it will be and a note will be kept securely in your University notes with an indication of who can access the information.

You are entitled to have one meeting per semester with your academic advisor in each year of your course. However, your academic advisor may ask you to come to see them more frequently and you should feel free to contact them if you need to see them urgently.

4.2 Student Experience Team

If you have any questions about or problems with life at our University, the first place to call, email or contact is the Student Experience Team. The team can help with a broad range of enquiries including: funding and money advice, being an international student, disability, counselling and wellbeing support, student cards, accommodation, fee payments, support from the Students' Union, how to access on-line services, getting help with your CV, preparing for an interview, careers guidance and getting a part-time job. Details of these and other services are available under the Support and Opportunities tabs in MyBeckett, or on the 'Students' homepage: www.leedsbeckett.ac.uk/studenthub.

You can find members of the Student Experience Team in the Student Hubs on the ground floor of the Rose Bowl at City Campus and in Campus Central at Headingley. Their telephone number is 0113 812 3000 and their e-mail address is studentexperience@leedsbeckett.ac.uk. They work closely with the course teams, the Students' Union, all University Services and external organisations to make sure that if they don't have the answer to your question they will know who will.

4.3 Students with disabilities

Support for students with disabilities is available from our Disability Advice team. Support is available for students with a range of disabilities including:

- epilepsy, diabetes and IBS
- depression, anxiety and eating disorders
- dyslexia, dyspraxia, and AD(H)D
- Autism Spectrum Conditions
- Mobility difficulties
- Sensory impairments

Support is individually tailored depending on the nature of your disability and the demands of your course.

5 What to do if you..

5.1 ...are absent for more than one day

You must notify your Course Administrator if you are absent for more than one day (for example for an interview, emergency unforeseen circumstances, or for compassionate leave). If you are going to apply for mitigation, you will need to provide written evidence of the reason for your absence (see section 3).

International Students

Please be aware that our University fully complies with United Kingdom Visas and Immigration (UKVI) policy at all times. There are legal reporting requirements for all students in the UK on a Tier 4 student visa, and full attendance is mandatory for all Tier 4 students. Failure to meet UKVI attendance requirements could lead to your academic sponsorship being withdrawn and your visa being revoked. Tier 4 students need to be aware of their responsibilities whilst in the UK, please see www.ukcisa.org.uk for full information.

5.2 ...are ill

If you are unable to study because of illness for more than seven consecutive days (including weekends), you must provide us with a **Fit Note**:

"A fit note (or Statement of Fitness for Work) allows your doctor or other healthcare professional to give you more information on how your condition affects your ability to work. This will help your employer understand how they might help you return to work sooner or stay in work. Fit notes may also be called medical statements or a doctor's note." (NHS Choices, n.d.)¹

You can send a digital copy of your Fit Note to your Course Director or Course Administrator, and then send the original by post.

If you are absent through illness on the day of an examination or assignment deadline and you intend to apply for mitigation, you must also provide us with details and any available evidence as soon as possible. Contact your Course Administrator to get a copy of the appropriate extenuating circumstances form.

5.3 ...have a comment, compliment or complaint

We are committed to providing a high quality experience for all our students. We welcome comments and compliments from students, and find them valuable for on-going improvements to our provision. Comments and compliments about your course can be raised with your Course Representative or directly with your academic advisor.

If you have a specific complaint about an act or omission of our University, you may be able to make a complaint under the Student Complaints Procedure. In the first instance, you should raise the matter as soon as possible with the member of staff most directly concerned, or with the person who can best resolve it. If this does not resolve the matter, or if the complaint is too serious to be addressed in this way, then you should make a formal complaint in writing. 5.4 ...are considering suspending studies or withdrawing from the course

If you are considering withdrawal from your course, you should speak to your personal tutor/academic advisor, a member of staff at our Student Hub or the Students' Union to discuss your reasons. If there is a problem, University or Students' Union staff may be able to help. It may be possible to arrange suspension of studies from your course.

Withdrawing from your course permanently or temporarily could affect the availability of future student funding should you decide to return to the course or commence a new

course at Leeds Beckett or elsewhere. Please seek advice from the Student Money Team or Students' Union Advice Team.

If you are considering withdrawing, permanently or temporarily, you must complete a withdrawal form, which you can obtain from your Course Administrator. This form must be submitted as soon as possible to your school office as withdrawals cannot normally be backdated. For further details see the Student Regulations at:

Policy Statement

Smoking

No smoking is permitted in any of our University buildings, this includes the use of vapour cigarettes (or other similar devices); if you do smoke outside our buildings please make sure that you stand at least five metres away from building entrances and boundaries.

Use of Laptops within our University

If you need to charge your laptop battery, please make sure that the battery charger/lead are undamaged, and only plug it into a designated power socket – if you are unsure of where these are, please ask a member of staff. Please make sure your battery charger cables do not create a trip hazard.

Fire Safety Procedures

Fire information is present on Fire Action Notices displayed in all our University buildings. These are normally present in corridors. Please read and follow the instructions.

All fire exit routes are clearly identified. You should familiarise yourself with the location of fire exit routes and fire assembly points for the buildings that you may use in the course of your studies which can be found on the blue and white Fire Action Notices. Use the nearest available route out which may not be the route you use daily to enter the building.

If you discover a fire, you should sound the alarm by operating the Fire Alarm Call Point. You should report the circumstances and site of fire using the emergency number 4444 - indicated on the Fire Action Notice.

Do not tackle the fire unless you have been trained to do so. Evacuate the building to the fire assembly point indicated on the Fire Action Notice. Do not re-enter the building until officially authorised to do so.

On hearing the Fire Alarm, everyone should proceed calmly to the nearest available safe fire exit, as indicated by the green and white fire exit signage. Take appropriate action to assist visitors and mobility-impaired persons or wheelchair users to a safe refuge.

Upon exiting the building, continue on to the fire assembly point so as not to impede the remaining evacuees exiting the building. Evacuation is practised through fire drills. However, you should regard any continuous sounding of the alarm as a fire incident and act accordingly.

Students with disabilities

You are expected to declare any disability that would affect your safety in the event of a fire, e.g. hearing impairment or the use of a wheelchair. If you are referred to the Disability Adviser, a Personal Emergency Evacuation Plan (PEEP) will be developed for you as appropriate.

Students with disabilities must declare their disability, to the University, for it to be taken into consideration. First Aid

First Aid Notices (green and white) are displayed in all University buildings alongside the Fire Action Notices (predominantly blue and white) and alongside, or adjacent to, each First Aid box. First Aid Notices provide all the information you may require to seek and summon assistance.

First Aider contact details can also be obtained from the Student Hub or from Security: City Campus, internal ext. 23154 or Headingley Campus, internal ext. 23165.

Accident and Incident Reporting

All accidents and incidents and dangerous occurrences, must be reported to, and recorded by University staff. Accident report forms (HS1) are available at reception offices, Security and Student Hubs.

Infectious Disease

Campus-based students who have been diagnosed with a serious infectious disease such as TB, measles, meningitis or chicken pox should notify their Course Director or Course Administrator as soon as possible giving information regarding which groups of students (and/or colleagues and clients on placements) you have been in contact with and when. For diseases such as TB or meningitis, the West Yorkshire Health Protection Team may also wish to speak to you (or your family) to determine if others require screening or medication. You

should follow advice given by the hospital or your GP about when it is safe to return to University.

Attendance Statement

The University expects you to attend and fully contribute to all mandatory sessions on your timetable as set out in your student contract. Engagement in your lectures, seminars and practicals is an important part of your learning - contributing to both the University community and the learning experience of your fellow students on the course.

We monitor your attendance at the University as regular attendance and academic achievement are closely linked. Moreover, by monitoring your attendance we can identify students who may need our guidance or support at an early stage to help them progress in their studies. This is part of our commitment to ensuring an excellent education and experience and supporting your success at Leeds Beckett.

The principal attendance system adopted within the University uses i-Beacons installed in all our teaching spaces which interacts with the Leeds Beckett application in your smartphone or tablet using Bluetooth technology. For those students who do not have a smart device you will be able to register manually via any student PC on campus allowing you to check in to your class. Some Schools may monitor your attendance via alternate methods which may include your lecturer asking you to sign a paper register.

The University does understand that from time to time, there is good reason why you cannot attend a class, and in this instance, you must contact your School office to let them know so the attendance system can be updated accordingly.

Please note that reports from the attendance system will allow attendance data to be shared with you and your Course team. You might be asked to contact the School office so that appropriate academic or pastoral support can be offered, should your attendance record give cause for concern.

Our most important aim is to support your studies, but we are also required to report attendance to various external bodies such as the Student Loan Company and the Home Office. There are measures in place for students who seek to falsely register either their own or fellow students' attendance.
