## Course Overview

### Aims

The aims of the programme are:

- transform students into sophisticated, independent and critical thinkers in the field of international relations
- provide students with an understanding of the concepts, theories and methods used in the study of international relations
- provide students with knowledge of the origins, evolution and contemporary dynamics of the international system and challenges to it.
- support students in their transition to postgraduate study so that all students will become confident in their academic and professional abilities and be able to apply their knowledge and skills within complex situations
- provide students with a thorough understanding of research, both as a practice and as a product, and be fully prepared for further development in either an academic, or professional, environment.

### Course Learning Outcomes

At the end of the course, students will be able to:

1	Demonstrate a sophistication in their critical thinking that reflects independence of thought and understanding of the political significance of multiple polities coexisting and of political boundary drawing and transforming practices
2	Apply concepts, theories and methods used in the study of international relations to analyse political ideas, practices and issues in the international system.
3	Demonstrate a knowledge and understanding of the origins, evolution and contemporary dynamics of the international system and the challenges to it.
4	Evaluate different interpretations of world political events within complex international situations.
5	Demonstrate a thorough understanding of research, both as a practice and as a product, and be fully prepared for further development in either an academic, or professional, environment.

# Teaching and Learning Activities

## Summary

Teaching methods will focus on small group discussion and debate, supported by mini lectures. These are supplemented where relevant by sessions in IT labs to develop skills using appropriate software. Students are encouraged to set their own tasks, within clearly identified structures, to meet the learning outcomes and assessment criteria. Similarly, reading lists are less prescriptive and encourage students to locate their own resources. Students will benefit from having access to outside speakers through the PIR seminar series which will broaden their learning experience. The VLE is used to provide materials but also a forum for discussion and the sharing of resources and thought.

The assessment balance and overall workload associated with this course are calculated from core modules and typical option module choices undertaken by students on the course. They have been reviewed and confirmed as representative by the Course Director but applicants should note that the specific option choices students make may influence both assessment and workload balance.

A standard module equates to 200 notional learning hours, which may be comprised of teaching, learning and assessment, any embedded placement activities and independent study. Modules may have more than one component of assessment.
