Course Overview

Aims

The aims of the programme are to:

- Transform students into sophisticated, independent and critical thinkers in the fields of peace and development.
- Provide students with an understanding of the concepts, theories and methods used in the study of peace and development.
- Provide students with knowledge of the origins, evolution and contemporary dynamics of peace and development within the international system and challenges to it.
- Support students in their transition to postgraduate study so that all students will become confident in their academic and professional abilities and be able to apply their knowledge and skills within complex situations.
- Provide students with a thorough understanding of research, both as a practice and as a product, and be fully prepared for further development in either an academic, or professional, environment.
- Enable students to apply their knowledge of peace and development with originality within advanced academic contexts.

Course Learning Outcomes

At the end of the course, students will be able to:

1	Demonstrate a sophistication in their critical thinking that reflects independence of thought and understanding of the nature and significance of peace and development as a human activity.
2	Apply concepts, theories and methods used in the study of peace and development to analyse practices and issues in the international system.
3	Demonstrate a knowledge and understanding of the origins, evolution and contemporary dynamics of peace and development within the international system and the challenges to it.
4	Evaluate different interpretations of peace and development within complex international situations.
5	Demonstrate a thorough understanding of research, both as a practice and as a product, and be fully prepared for further development in either an academic, or professional, environment.
6	Demonstrate knowledge with originality, through the production of a significant piece of high-level independent work in the fields of peace and development.

Teaching and Learning Activities

Summary

Teaching methods will focus on small group discussion and debate, supported by mini lectures. These are supplemented where relevant by sessions in IT labs to develop skills using appropriate software. Students are encouraged to set their own tasks, within clearly identified structures, to meet the learning outcomes and assessment criteria. Similarly, reading lists are less prescriptive and encourage students to locate their own resources. Students will benefit from having access to outside speakers through the Politics & International Relations seminar series which will broaden their learning experience. The VLE is used to provide materials but also a forum for discussion and the sharing of resources and thoughts.
