Aims

The course aims to provide:

- 1. A learning environment which places intersectional analyses of race, racism and decoloniality at its centre;
- 2. Research training in qualitative and quantitative methods to enable students to be confident researchers in the areas of race, racism and decoloniality in a variety of societal and professional contexts including education
- 3. The possibility to complete at PG Diploma level as well as MA.
- 4. Provide a global outlook by analysing examples of racialized inequalities from contexts in the global South.

Teaching and Learning Activities

Summary

The programme will develop communities of practice through both face-to-face and distance teaching and learning. For face-to-face delivery, most modules will utilise seminars for group discussion, presentations, feedback and collaborative learning and will be led by academic staff with relevant research expertise. For distance learners, our work with the Distance Learning Unit (DLU) will ensure that course materials are presented appropriately and that students are actively engaged in online learning through the creation of online communities, which are actively supported by academic staff.

Regardless of learning mode, each student will be allocated a personal tutor who will be able to support them in their academic work throughout the modules through structured and responsive coaching tutorials.

All modules will be delivered and facilitated by research active staff who will be able to scaffold links between research and practice and thereby help students to construct their own lines of enquiry and knowledge through the undertaking of a dissertation.

Assessment Balance and Scheduled Learning and Teaching Activities

The assessment balance and overall workload associated with this course are calculated from core modules and typical option module choices undertaken by students on the course. They have been reviewed and confirmed as representative by the Course Director but applicants should note that the specific option choices students make may influence both assessment and workload balance. A standard module equates to 200 notional learning hours, which may be comprised of teaching, learning and assessment, any embedded placement activities and independent study. Modules may have more than one component of assessment.

Assessment

On this course students will be assessed predominantly by coursework and all summative feedback, including that which informs practice, will be distributed via Turnitin. This is to provide a more efficient and streamlined experience for the students. The Turnitin feedback will consist of comments and a 'rubric' of grades descriptors. Annotations added to the script will usually be related to the grades descriptors. In line with the programme's Assessment Strategy, summative assessment on each final assessment piece will also provide key targets which can be acted upon for future assignments, with the support of the personal tutor as appropriate.

Within each module on MyBeckett, students have access to a section called "Assessment", which includes a summary of the assessment; submission details (date and time, method of submission, feedback date) and marking criteria (either provided on screen or via a link to a document with these details). In addition, students have access to the relevant information in their Module Handbook.

Workload

The number of hours of workload generally equates to 1200 for PG Diplomas corresponding to the national standard of 10 notional hours of learning for each UK HE credit point.
