Graduation – Presiding officer

Purpose

To note the delegation of authority from the Vice Chancellor to Deans of School, in addition to Deputy and Pro-Vice Chancellors to preside at graduation ceremonies.

Key Issues

Graduation ceremonies will return in July 2022 following their suspension during the pandemic. The ceremonies in July 2022 will take place over seven days and require more flexibility in the designation of the presiding office, to manage the number of graduands and guests.

- 1. The University has announced graduation ceremonies for the classes of 2020, 2021, and 2022 from 14-22 July to be held in Leeds first direct Arena. There will be seven full days of ceremonies in July, three each day, at 10:00, 13:00 and 16:00. This could represent a significant increase in time commitment from colleagues across the university and the scale and formal requires some flexibility in their operation for this year and to allow further development in future years.
- 2. At present the Vice Chancellor is designated as the presiding officer with only Deputy Vice Chancellors currently authorised to deputise. Deans of School will therefore also be authorised and designated as the presiding officer for ceremonies. This will also allow us to retain flexibility in how we organise ceremonies and celebration events in future years and based on student feedback allow us to focus celebrations not only around a University ceremony but a student's academic school and course team.

Purpose of Report

Action Requested

Key Issues

1. It is proposed to amend the terms of reference of the Academic Programmes & Collaborations Group (APCG) in order to make it a formal sub-committee of the Academic Board. The Group's remit to the Academic Board will be advisory and it will also form a part of the new Degree Apprenticeships governance structure to align discussions about academic planning and collaborations across all types of provision.

Governance considerations

- 2. The current terms of reference and membership profile of APCG are attached. It is not proposed to make any substantive changes to these as part of this process.
- 3. As a sub-committee of Academic Board however, it should be noted that any future changes to its terms of reference or membership profile should be approved by Academic Board in line with the University's Articles of Government (Article 6) and the Standing Orders.
- 4. Consideration should also be given to the Standing Orders when scheduling meetings, circulating papers and in the conduct of meetings. A summary report of the most recent meeting should be included on the agenda for Academic Board meetings.
- 5. Article 6 also requires the approval of the Board of Governors to formally establish a new Academic Board sub-committee.

Recommendations and next steps

6. Academic Board members are invited to consider this proposal and recommend that the Board of Governors gives its approval at its meeting on 20 May 2022.

For New Courses:

- Course title;
- Market demand / opportunity and internal /external competition;
- Resources (physical and academic staff);
- Impact on other courses.

For New Collaborative Partnerships:

- Nature and standings of partner;
- Region;
- Resources;
- Impact on other courses;
- Impact on other activity in the region.

Proposals will be supported, either by the 'standing' school representatives, or through participation from the course team developing the proposal.

Proposals endorsed by the Group can move forward to formal validation. Where there are issues which need to be resolved prior to validation, proposals will be referred back to the relevant School for action.

The Group will also receive and consider proposals for suspension of recruitment, course withdrawals and articulation agreements.
