PRELIMINARY ITEMS

Terms of reference and membership

- 001.2223 (a) The report was received without discussion.
 - (b) Dr Andrew West, Chair of the Committee, welcomed Ashleigh Pinnock, new student governor and SU Welfare & Communities Officer, to her first meeting of the committee.

Declaration of interest

002.2223 Declarations of interest were received from Dr Andrew West and Nick Whitaker, relating to the agenda item proposing remuneration for the chairs of Committees (minutes 023 and 024.2223 refer).

Minutes

003.2223 The Committee **agreed** that the minutes of its meeting on 10 June 2022 were an accurate record.

Matters arising

004.2223 (a) The Secretariat Manager provided the Committee with an overview from the Students' Union (SU), in response to queries from the meeting 10 June 2022 regarding low turnout during elections. To promote opportunities, the SU's marketing team implemented an annual communications campaign about elections and representation opportunities. Student-facing teams such as the Student Voice & Insight team engaged with students at events on campus or remotely. It was acknowledged by the SU that there was perhaps more focus on students already in "leadership" roles. These included course reps and equality community leaders who had already taken the first steps.

- (b) This year the Student Voice Insight team would expand this activity and would visit courses as part of induction talks to promote elections and the importance of voting more broadly. Linked to this were plans to promote external social responsibilities including registering to vote in local and national elections with the council. The student governor and SU Welfare & Communities Officer noted that increasing engagement and promoting SU democracy formed part of the officer objectives for the 2022/23 academic year.
- (c) The Deputy Secretary and Student Casework Manager had met the SU's Head of Membership Engagement and Student Voice Manager in March 2022 to consider immigration issues relating to international Masters students starting in September and whose studies would be disrupted if they stood for and were successful in an campaign. Guidance had been shared with the SU to help them find a way forward.
- (d) The Committee welcomed the proposed action from the SU to improve turnout in elections. It was noted that a suggestion from the recent governance effectiveness review was for the Board to consider ways in which governors could further engage with the University's students. This would be included on the action plan for 2022/23.
- 005.2223 The Committee **agreed** that the Governor Code of Conduct should be reviewed in full for the next meeting, with regular reviews to be conducted in the future.



 - (b) The Head of Procurement reported that the Procurement Strategy had been refreshed with Modern Slavery now included in the strategic objectives.


010.2223 The Committee **resolved** to approve the University's Modern Slavery Act Transparency Statement for publication on the website.

(d) The University executive would sign off the University's submission to the consultation with the draft APP coming through to the Committee in due course.




(b) The Committee was pleased to see this feedback and how it aligned with away day discussions, highlighting the importance of the Board being able to set its own strategic agenda.

Induction, Pairing and Development Update

- 018.2223 (a) The Committee noted an overview of the current induction offering for new governors which had generated positive overall feedback, with new governors feeling well supported with by an effective induction and access to information.
 - (b) There was a brief discussion about options for continuing the programme of informal governor briefings in 2022/23. It was proposed a regular Friday morning slot was agreed, with suggested first areas of focus to be around the academic cycle and assurance, including the degree algorithm and grade inflation, external examiners, and a more general briefing on the work of Quality Assurance Services. Equality, diversity and inclusion, and Degree Apprenticeships were also on the list proposed by Chairs' Committee at its meeting in September 2022.










Annual Review and Remuneration of the Committee Chairs 2021/22
