Overall performance of students is good. Great to see a number of high achievers. However, disappointing to see so many students not completing their resit work.

Of the work that I saw, students are the weaker end of the spectrum need to consider their research projects in more depth as well as research more widely. It is clear that students at the higher end have taken time to consider their methodology carefully and have researched more widely.
