I cannot comment on the actual board as I was unable to attend in this occasion. However, the support team kept me updated on all the processes.

I had asked to see the proposals so to be able to comment on students' progression on formative feedback. Unfortunately, this was not possible this year.

(c) The overall performance of the students, in relation to that of comparable levels of work in other institutions.
The overall performance of students seems comparable to the one in other institutions I am familiar with.

(d) The strengths and weaknesses of the students in general with respect to knowledge, conceptual grasp or application of skills.
The works I reviewed confirm once again that the students are able to link theory and practice. Students still seem to find processes of theorising challenging.

For this board, I was asked to observe only dissertations. They seem of adequate level overall. The team gave appropriate feedback. I commented on how different institutions have introduced different levels of moderation to ensure consistency across different supervisory teams. This would also support more fairness across different marking teams.

It will be beneficial to discover more about the university processes to review and refresh the curriculum. I will liaise with the course team to access this information.

I had limited opportunities to access the MyBeckett VLE.

I was only able to comment on the dissertations. In this assessment, the learning outcomes were clearly laid out and measured with appropriate marking grids. I commented to the school separately on how there might be benefits in harmonizing feedback forms.

Next year, I would appreciate to have a clearer presentation on how the supervisory arrangements are structured to guarantee similar experiences for all students in the process.
